The Science Center offers permanent and traveling exhibitions, salt and fresh water aquariums, a planetarium, a performance theater, and an outdoor science-themed trail and includes a volunteer staffed ham radio center that allows visitors to communicate with operators throughout the world.

4b (Code: ) (Expenses \$ 728,837. including grants of \$ ) (Revenue \$ 351,074.) Provided educational science-based programming to over 60,000 pre K-12 students at SFSC&A, and held summer science camps for over 1,600 children ages 4-12 years old. The Center also held professional development workshops for over 100 teachers throughout the year. Almost 40% of the students we serve are from under-served communities through free programming. Our education department serves the eleventh largest school district in the nation under a district-wide agreement.
